What is DRM?

Digital Restrictions Management

DRM

- is proprietary software;
- imposes artificial restrictions on usage, e.g.;
 - limits usage of media to certain devices;
 - limits saving a video when streaming;
 - playing a game without its CD in the drive;
 - playing a single player game offline.

It limits your freedom to use and share media, hence it is defective by design.

Digital Restrictions Management

DRM vendors **claim** that their software **enforces copyright**. *It does much more than that*.

It disables rightful usage of media: home copies, playing a Blu-Ray on your home theatre system, recording music from streaming services for your own use, ...

It **spies** on its users by sending back info on how the media was used.

DVD

DVD copying was impossible for a while. DRM called "Content Scrable System" (CSS) disabled it.

The system was introduced around 1996 and was first **compromised** in 1999.

Sony: Blu-Ray

Blu-Ray's use "Advanced Access Content System" (AACS), which is build by **less laughable** software engineers.

Blu-Ray discs can **fight back**. Newer discs sometimes take time before they are cracked.

Telenet: Yelo and CI+

Yelo, the online television service, uses *ReadyPlay* (by Microsoft). ReadyPlay has a "blackbox DLL", that executes **any instruction** it gets from Microsoft and **sends usage statistics** back. Not to Telenet, **to Microsoft**.

CI+ ("TV met een kaartje") makes it impossible to watch digital TV on your computer (or HTPC) without Telenet's explicit per-device permission.

Some ways to oppose DRM:

- ▶ Crack existing DRM solutions → illegal;
